Documents to be upload by the applicant (Select any drop down and upload below documents only)

1. Attested copy of NZ passport / foreign passport
2. Attested copy of citizenship certificate if born outside NZ / else upload birth certificate
3. Attested Marriage certificate
4. Spouse OCI card copy and Spouse indian passport copy - Applicant name should be added on spouses OCI or Indian passport of spouse
5. OCI Undertaking form

Justice of Peace / Registrar Attested copies only (Note: No solicitor attested documents will be accepted & if Self Attested copies same needs to be done on the counter with original documents)

List of Attested documents to be sent along with application no original documents are required if its attested

- 1.Copy of JP Attested current New Zealand / foreign passport of applicant and spouse
 - 2.Copy of JP Attested Citizenship Certificate of the applicant if born outside NZ
 - 3.Copy of Apostilled birth certificate of foreign spouse required
 - 4.Copy of Birth certificate/ Apostilled birth certificate of the foreign spouses parents/ grandparents/great grandparents required
 - 5.Undertaking form for spouse - Form in (<https://www.hciwellington.gov.in/content/OCI-UNDERTAKING.pdf>)
 - 6.Spouse OCI card copy and Spouse Indian passport copy - Applicant name should be added on spouses OCI or Indian passport of spouse
- Copy of Marriage Certificate – Apostilled / authenticated by the Government of the country of issue if marriage is registered in a foreign country.
- If already a PIO Card holder, then the copy of the PIO Card.
- Previous Indian Visa (if available).
