| <p><b>Following is mandatory if the Passport has expired more than one year ago:</b></p> <ul style="list-style-type: none"> <li>● <u>Local Police Clearance Certificate</u> from Ministry of Justice, New Zealand</li> <li>● <u>Letter from applicant</u> giving reason for not renewing the passport within a year of date of expiry.</li> </ul>   |
