

Checklist for Reissue of passport

<p>All applicants must complete online Passport Application Form At: http://passport.gov.in/nri/Online.do using "Firefox Mozilla" or "Google Chrome" web browser to generate application form (Online registration form may not be compatible with "Internet Explorer" browser). Passport Online Application should be accurately filled.</p>	
<p>Fee of NZ\$ 112 (for normal re-issue of passport) Fee of NZ\$ 221. (in case of lost/damaged passport) Fee can only be paid by Banker's Cheque/bank Draft drawn in favour of "High Commission of India Wellington". * We do not accept personal cheques/Money orders/Credit Card. ** Cash is accepted at the counter if application is submitted in person.</p>	
<p>Copy of valid New Zealand visa [If visa is not stamped on the passport]</p>	
<p>Original Indian passport (Not attested copies please) (not applicable for lost passport applicants) All the submitted passports will be returned after re-issue of new passport</p>	
<p>Four recent photographs of 2 inches X 2 Inches (51mm X 51mm) with light background. Please paste one photo on the Passport application. Please paste one photo on the Personal Particular form. Do not staple/pin the photographs.</p>	
<p>Annexure "E" must be completed and signed by the applicant. .</p>	
<p>Personal Particulars Form</p>	
<p>In case of change of appearance Annexure 'J' duly attested by Justice of Peace/notary. Fee of NZ\$ 40 (This fee is in addition to the passport fee)</p>	
<p>In case of Lost passport ONLY- Copy of passport Annexure "F" for Lost passport attested by JP. Police report in original (the Police report MUST include Passport number) Letter from Employer/institution/organization confirming employment /enrolment Copy of Drivers Licence/PAN Card/any other Photo ID Attested by Justice of Peace</p>	
<p>Annexure "F" for Damaged passport attested by JP in case of damage passport</p>	
<p>In case of Change in Address please attach any two of the following:</p> <ul style="list-style-type: none"> • Water/Electric/Telephone/Gas connection bill/Drivers Licence • Valid Ration card/ Aadhar Card/ Election Commission photo ID 	
<p>Following is mandatory, if the passport has expired more than one year ago</p> <ul style="list-style-type: none"> • Letter confirming "Denial of New Zealand Citizenship" (Please contact the <i>Department of Internal Affairs, New Zealand-</i> www.dia.govt.nz) • Local Police Clearance certificate from Ministry of Justice, New Zealand 	
<p>Self-addressed prepaid courier envelope to return your passport.</p> <p>The applicant may use any courier service (with tracking facility) of their choice and are advised to keep the tracking numbers with them as High Commission of India will not take any responsibility in case the courier is lost/misplaced/damaged or delayed. Please do not send the application via ordinary post. Before making any status enquiry about the application please check with the courier service whether the application has been delivered to our office.</p>	
<p>Interview with Passport Officer may be required on case to case basis.</p>
